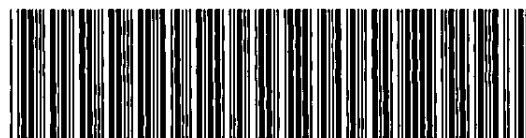

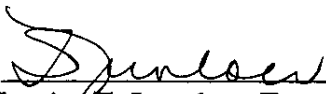
ARTICLE VIII. AMENDMENT

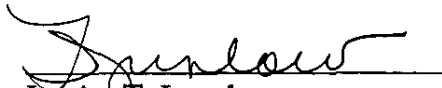
