1. Name. The name of the corporation is: COLOR MEDIC, INC.
2. Purpose. The corporation may engage in any legal business.
3. Stock. The maximum number and class of shares of capital stock this corporation is authorized to have outstanding is 1000 shares of common capital stock with no par value. The corporation shall have a lien on its shares of stock for any debt or liability incurred to it by a stockholder before being notified of the transfer or levy on such shares.
4. Existence. The corporation shall have perpetual existence. The corporation shall commence existence on March 30, 2007.
5. Registered Agent. The initial street address in the State of Florida of the initial registered office of the proposed corporation is 48 Almond Road, Ocala, FL 34472 and the name of its initial registered agent at such address is JASON CHISM.
