
ARTICLE IX



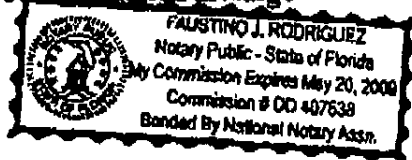
