ARTICLES OF INCORPORATION
OF
BIG CYPRESS TITLE COMPANY

The undersigned, acting as Incorporator, signs the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida.

ARTICLE I

The name of the corporation shall be:

BIG CYPRESS TITLE COMPANY (the "Corporation")

ARTICLE II

The existence of the Corporation shall commence upon the filing of these Articles of Incorporation by the Florida Department of State and shall be perpetual.

ARTICLE III
