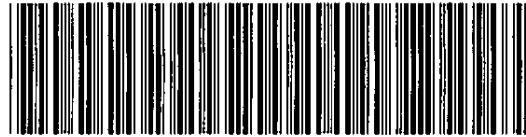

**ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION OF
SOUTHERN GROUP LAND DEVELOPMENT, INC.**
