### AMENDED AND RESTATED ARTICLES OF INCORPORATION

# OF

#### SUNSHINE STATE HEALTH PLAN, INC.

Pursuant to Section 607.1006 of the Florida Business Corporation Act, the corporation hereinafter named (the "Corporation") hereby amends its Articles of Incorporation.

- 1. The name of the Corporation is Sunshine State Health Plan, Inc.
- 2. Article IV is hereby deleted in its entirety and replaced with the following:

"The number of shares which the Corporation shall have authority to issue is two thousand (2,000) shares of common stock, with a par value of One Dollar and 00/100 (\$1.00) per share."

3. Except as set forth in Section 2 above, the Amended and Restated Articles of Incorporation are not otherwise amended and shall remain in full force and effect.
