ARTICLES OF INCORPORATION

OF

The undersigned, a natural person competent to contract and a medical doctor duly licensed under the laws of the State of Florida, does hereby make, subscribe and file these Articles of Incorporation for the purpose of organizing a professional association under the Professional Service Corporation and Limited Liability Company Act and other applicable laws of the State of Florida.

ARTICLE I

CORPORATE NAME

The name of this Corporation shall be IRA M. FELDMAN, M.D., P.A.

ARTICLE II

NATURE OF CORPORATE BUSINESS

The general nature of the business to be transacted by this Corporation shall be:

A. To engage in every aspect and phase of the practice of rendering the same professional services to the public that medical doctors, duly licensed under the laws of the State of Florida, are authorized to render; provided, however, that such professional services shall be rendered only through officers, employees and agents of this Corporation who are duly licensed as medical doctors under the laws of the State of Florida.

To invest and reinvest the funds of this Corporation in real estate, mortgages, stocks, bonds or any other types of investments within the meaning of Section 621.08 of the Florida Statutes, and to acquire and own real and personal property necessary for the rendering of professional services as a medical doctor.

C. To conduct and transact any business lawfully authorized and not prohibited by Chapter 621 of the Florida Statutes, as the same may be amended from time to time.
