***DURATION:***



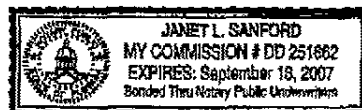
