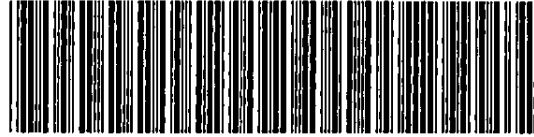

The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a Corporation for profit under the provisions of Chapter 607 of the Florida Statutes.

ARTICLE I

Name

The name of the corporation shall be Kabler Enterprises, Inc., (hereinafter, "Corporation").

ARTICLE II

Location

The principle place of business and mailing address of the corporation is 27431 State Road 54, Zephyrhills, Florida 33543.

ARTICLE III

Purpose

The corporation may transact any lawful business for which corporations may be incorporated under Florida Law.

ARTICLE IV

Authorized Stock

The aggregate number of shares of stock authorized to be issued by this corporation shall be 5,000 shares of common stock, each with a par value of One Dollar. By-Laws

The Corporation shall have perpetual existence.

ARTICLE XII

Effective Date

These Articles of Incorporation shall be effective April 1, 2007 upon approval of the Secretary of State, State of Florida.

ARTICLE XIII

Amendment


