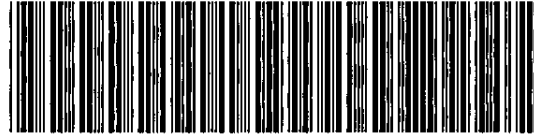



**The undersigned does hereby form a corporation under Chapter 607 of the laws of the State of Florida.**

**ARTICLE I. -- NAME AND ADDRESS**




