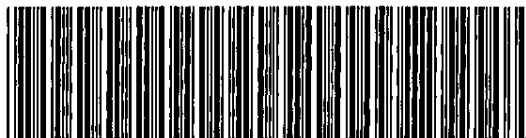



ARTICLES OF INCORPORATION
OF

The undersigned natural person, who is licensed or otherwise legally authorized to practice the profession of law in the State of Florida, hereby associates himself with the intention of forming a professional corporation in accordance with the Florida Professional Service Corporation Act, and hereby adopts the following Articles of Incorporation for such corporation.

ARTICLE I

Effective Date

The date when the corporate existence of this corporation shall commence shall be April 7, 2007.

ARTICLE II

Name

The name of the corporation is DUNHAM PAINTING & FAUX FINISHES, INC.

ARTICLE III

Duration

The period of the corporation's duration shall be perpetual or until dissolved.

ARTICLE IV

Purpose

This corporation is organized for the following purposes:

- a. To engage in the business of painting and to carry on services incident thereto. Painting is the sole and exclusive business to be rendered by this corporation.

b. To own property, enter into contracts, and to carry on any business necessary or incidental to the accomplishment or furtherance of the purposes or objects of this corporation.

c. The professional services of this corporation shall be carried out only through officers, employees, and agents, each of whom has been admitted to work in the State of Florida.

ARTICLE V

Capital Stock

The total number of shares of capital stock, which the corporation shall be authorized to issue is one thousand (1000) shares without par value.

ARTICLE VI

Principal Office

The address of the corporation's principal office is 41 South Orchard Street, Ormond Beach, Florida 32714

ARTICLE VII

Registered Agent

The registered office of the corporation is 41 South Orchard Street, Ormond Beach, Florida 32714, and the name of the initial registered agent of the corporation located at such office is Eric Dunham Lang.

ARTICLE VIII

Corporate Powers

The corporation shall have all the rights and powers now or hereafter conferred on professional corporations by the laws of the State of Florida.

By-Laws


The internal affairs of the corporation are to be regulated and managed in accordance with By-Laws to be adopted by the Board of Directors.
