# ARTICLES OF INCORPORATION THE PARK APARTMENTS OF SOUTHWEST FLORIDA, INC.

A: A: A STATE OF STAT THE UNDERSIGNED, acting as sole incorporator of a Corporation to be formed under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

#### ARTICLE I:

The name of the Corporation (the "Corporation") is: The Park Apartments of Southwest Florida, Inc.

#### ARTICLE II:
