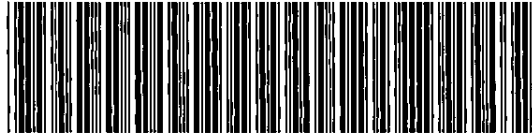





Article – Fourteen



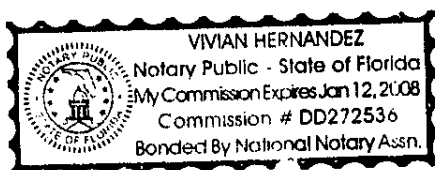



