

ARTICLES OF INCORPORATION
OF

NV ENTERPRISES, INC

Article I - Name

The name of this corporation is NV ENTERPRISES, INC

Article II - Duration

This corporation shall exist perpetually commencing on April 1, 2007.

The directors of this corporation may take action by written consent, as provided by law.


Article XI - Indemnification
