

**ARTICLE I
CORPORATE NAME**

DURATION**



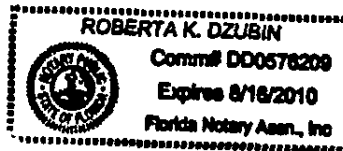
