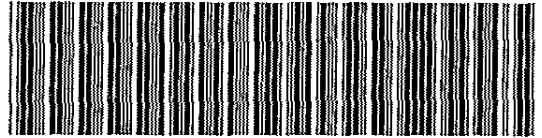



CORPORATE NAME AND ADDRESS
