ARTICLES OF INCORPORATION
OF

Martin Auto Transport. INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following Articles of incorporation.

ARTICLE ONE

NAME

The name of the corporation is Martin Auto Transport INC.

ARTICLE TWO

DURATION

The term of existence of the corporation is perpetual, and shall be deemed to have commenced its existence on the 2nd day of April 2007

ARTICLE THREE

PURPOSE

The purposes for which the corporation is organized are:

- a. Transport of vehicules for 3rd party
- b. To establish and maintain offices for any and all operations of this corporation at such places to be

determined by the directors, wheresoever the same may be located.

- c. To contract any and all lawful business for which a corporation may be incorporated under the Florida General Corporation Act and all amendments, thereto


ARTICLE EIGHT


