## ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation.

# ARTICLE I - NAME

Section 1.1 Name. The name of the corporation is Leslie's Restaurant & Bakery, Inc.

# ARTICLE II - INITIAL PRINCIPAL OFFICE AND MAILING ADDRESS

Section 2.1 <u>Initial Principal Office and Mailing Address</u>. The initial principal office and mailing address is 2574 County Road 220, Suite 4, Middleburg, Florida 32068.

#### ARTICLE III - DURATION

Section 3.1 <u>Duration</u>. This corporation shall exist perpetually. Corporation existence shall commence on April 20, 2007.

#### ARTICLE IV - PURPOSE

Section 4.1 <u>Purpose</u>. This corporation is organized for the purpose of transacting any or all lawful business permitted under the laws of the United States and of the State of Florida.

#### ARTICLE V - CAPITAL STOCK
