ARTICLE INAME

The name of the corporation is Trad's Indoor Pest Control, Inc.

ARTICLE IIGENERAL PURPOSE OF CORPORATION

The specific purpose for which this corporation is organized is the following:

- a) To engage in and transact any business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.
- b) To do such other things as are incidental to the purpose of the corporation or necessary or desirable in order to accomplish them.
- c) To do general household pest control, which term means pest control with respect to any structure, not including fumigations or pest control with respect to termites and other wood destroying organisms.

ARTICLE IIICAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to have outstanding at any time is five hundred (500) shares of common stock, each having the par value of One Dollar (\$1.00). The whole or any part of the capital stock of this Corporation shall be payable in lawful money of the United States, or in property, labor, or services.

ARTICLE IVINITIAL CAPITAL

The amount of capital with which this Corporation shall begin business is not less than Five Hundred Dollars (\$500.00).

ARTICLE VTERM OF EXISTENCE

The Corporation shall have perpetual existence.

ARTICLE VI

ADDRESS

The principal address of the Corporation is 8178 San Jose Boulevard, Jacksonville, Florida 32217. The initial Registered Agent of the Corporation shall be Louis Trad, Jr., 8178 San Jose Boulevard, Jacksonville, Florida 32217.

ARTICLE VII

BOARD OF DIRECTORS

The initial Board of Directors shall consist of two (2) persons. The number of Directors may be increased or decreased from time to time in accordance with the Bylaws, but shall never be less than one (1). The name and address of each initial Director of the corporation is as follows:

ARTICLE IX

RESTRICTION OF SALE OF STOCK

The Corporation shall have the power to include in its By-laws any regulatory or restrictive provisions relating to the proposed sale, transfer or other disposition of any of its outstanding stock by any of its Stockholders. The manner and form, as well as all relevant terms, conditions, and details hereof shall be determined by the Stockholders of this Corporation; provided, however, that no such regulatory or restrictive provisions shall effect the rights of third parties without actual knowledge thereof, unless such provisions shall be plainly written upon the Articles of Incorporation evidencing the ownership of said stock.


ARTICLE X


