## ARTICLES OF DISSOLUTION

Pursuant to Section 607.1403, Florida Statutes, Trad's Indoor Pest Control, Inc., a Florida corporation (the "Corporation"), submits the following Articles of Dissolution:

#### ARTICLE I

The name of the corporation is Trad's Indoor Pest Control, Inc. The document number for the Corporation is P07000043480.

#### ARTICLE II

The voluntary dissolution of the Corporation is authorized as of February 6, 2013.

#### ARTICLE III

The dissolution of the Corporation was approved by the shareholders of the Corporation holding a majority of the issued and outstanding stock of the Corporation entitled to vote.

#### ARTICLE IV

These Articles of Dissolution shall become effective on February 6, 2013, except that if these Articles are not filed by the Department of State of the State of Florida on or before such date, corporate dissolution shall become effective upon filing by the Department of State, and the Corporation shall be dissolved as of such date.

#### ARTICLE V


