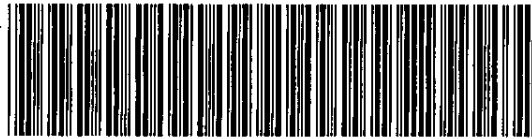

ARTICLE IX

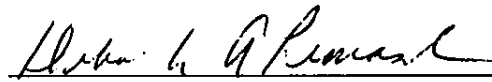
AMENDMENT

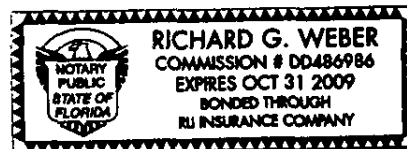
