**ARTICLES OF INCORPORATION
(Professional Corporation)

The undersigned, who is duly licensed to act as a salesperson in the State of Florida desires to form a professional corporation in accordance with the Florida Business Corporation Act and the Florida Professional Service Corporation and Limited Liability Company Act, hereby adopt, the following Articles of Incorporation:

I. NAME

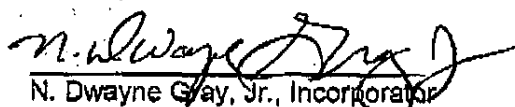
