Pursuant to the requirements set forth in Chapter 607 of the Florida Business Corporation Act, the undersigned, being a natural person, does hereby act as the incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I - NAME**

The name of the corporation (hereinafter referred to as the "Corporation") shall be **JJS Consulting Services, Inc.**

**ARTICLE II - ADDRESS**

The street address of the principal office and mailing address of the Corporation is 1928 Bluebonnet Way, Orange Park, Florida 32003.

**ARTICLE III - PURPOSE**

The purpose in which this Corporation is organized is to engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, county, territory or nation.

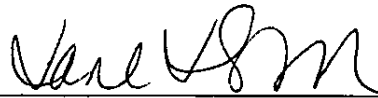
**ARTICLE VII – REGISTERED AGENT**
