The undersigned, duly licensed to practice veterinary medicine in the State of Florida, desiring to form a professional corporation, in accordance with Chapters 607 and 621 of the Florida Statutes, does hereby adopt the following Articles of Incorporation.

**ARTICLE I  
NAME**

The name of the Corporation shall be:

**ARTICLE II  
COMMENCEMENT OF CORPORATE EXISTENCE**

The Corporation shall commence its existence as of the date of filing of these Articles.

**ARTICLE III

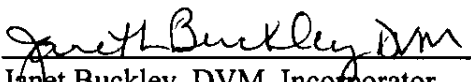
