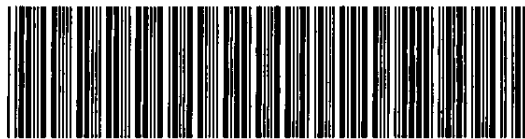

ARTICLES OF INCORPORATION
OF
501-C EQUIPMENT, INC.

The undersigned for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE ONE
NAME

The name of the corporation is 501-C EQUIPMENT, INC.

ARTICLE TWO
DURATION

The term of existence of the corporation is perpetual.

ARTICLE THREE
PURPOSE

The purpose for which the corporation is organized is to provide equipment and consultation services to non-profit entities for profit.

The corporation may transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

ARTICLE FOUR
CAPITAL STOCK

The aggregate number of shares which the corporation has authority to issue is one thousand (1,000), all of which shall be common shares with no par value.

ARTICLE FIVE
PREEMPTIVE RIGHTS GRANTED

Each shareholder of any class of stock of this corporation shall be entitled to full preemptive rights to purchase any unissued stock or treasury shares of the corporation and any securities of the corporation convertible into or carrying the right to subscribe to or acquire shares of any such unissued stock or treasury shares.

ARTICLE SIX
PRINCIPAL OFFICE

The address of the principal office of the corporation is: 5923 Trailwood Drive, Port Orange, Florida 32127. This is also the mailing address of the corporation.

ARTICLE SEVEN
REGISTERED OFFICE

The street address of the registered office of the corporation is 5923 Trailwood Drive, Port Orange, Florida 32127, and the name of the initial registered agent at such address is Jeffrey G. Haidle.

ARTICLE EIGHT
DIRECTORS

The board of directors shall consist of one member, Jeffrey G. Haidle, 5923 Trailwood Drive, Port Orange, Florida 32127.

ARTICLE NINE
INCORPORATORS


ARTICLE ELEVEN
