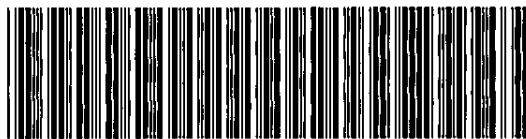



The name of this corporation is **BEUTEN INDUSTRIES, INC.**



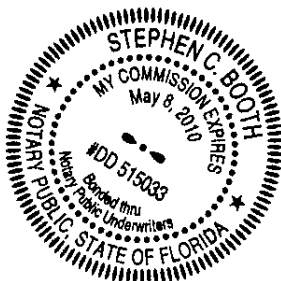


