ARTICLES OF INCORPORATION

OF

JOE BLASCO ENTERTAINMENT, INC.

ARTICLE I – NAME

The name of the corporation shall be: JOE BLASCO ENTERTAINMENT, INC., (hereinafter referred to as the "Corporation").

ARTICLE II – DURATION

This corporation shall exist perpetually, commencing on the date of filing of these Articles.

ARTICLE III - PRINCIPAL PLACE OF BUSINESS

The principal place of business of JOE BLASCO ENTERTAINMENT, INC. shall be: 521 North Kirkman Road, Orlando, Florida 32808

ARTICLE IV – PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes provided that it will not engage in any act or activity requiring the consent or approval of any government official, department board, agency or other body of any local, state or federal government having jurisdiction over such act or activity, without obtaining such consent or approval.

ARTICLE V - CAPITAL STOCK

The maximum number of shares of capital stock that this corporation is authorized to issue and have outstanding at any one time is 100 shares of common stock having a par value of \$1.00 per share, which may be fractional shares.

- B.
