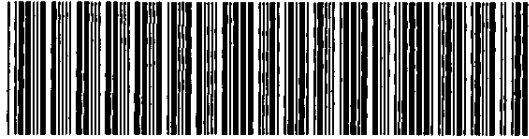



ARTICLES OF INCORPORATION OF C'EST ICI, INC.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I-NAME

The name of the Corporation shall be C'EST ICI, INC. (the "Corporation").
