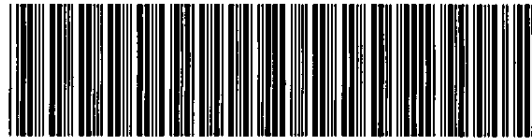

**ARTICLE I:** The name of this corporation is TRUE HOUSE SUPPLY, INC.

**ARTICLE II:** This corporation shall have perpetual existence.
