



ARTICLES OF INCORPORATION

of

ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS

The name of this corporation is **SCRUB DUB DUB CLEANING SERVICES, INC** and its principal place of business shall be located at **5651 NW 140th St. Chiefland, FL 32626.**

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue one thousand (1000) shares of common stock at **TWO DOLLARS (\$2.00)** par value, which shall be designated as "Common Shares."

ARTICLE X - INDEMNIFICATION


