

The undersigned incorporator, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name and address of this corporation shall be:

ARTICLE II - EXISTANCE

The corporation shall have perpetual existence.

ARTICLE III - PURPOSE OF CORPORATION

ARTICLE IV - CAPITAL STOCK

ARTICLE IX - BY LAWS


The power to adopt, alter, amend or repeal by-laws shall be vested in the Board of directors and shareholders.


