ARTICLE OF INCORPORATION
OF
GAQ CORPORATION

I, the undersigned, being of legal age and a natural person, do hereby subscribe to, acknowledge and the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE I

The name if this corporation shall be:

GAQ CORPORATION

ARTICLE II

The general nature if the business to be transacted by the corporation is as follows:

1. The corporation may engage in any activity or business which is permitted under the laws of the United States, the State of Florida or any other state, County, Territory or Nation.
2. And in general, to carry on any other business whatsoever in connection with the foregoing or which is calculated, directly or indirectly, to promote the interest of the corporation or to enhance the value of its properties.
3. And, further, to borrow or raise money for any purpose of the company and to secure the same interest, or for other purposes, to mortgages all or part of the property corporeal or incorporeal right or franchise of this company now owned or negotiate bonds and mortgages, bills of exchange, promissory notes or other obligations or negotiable instruments.

ARTICLE III

The capital stock authorized, the par value thereof, and the characteristics of such stock shall be as follows:

500 Shares of Common Stock- Par Value \$1.00

All of said stock shall be payable in cash, property, real or personal, labor or services in lieu of cash, at a just valuation to be fixed by the Board of Directors of this corporation. This payment thereof does not have to be at the time of issuance, provided that said shares are subject to calls, thereon until the whole consideration therefore shall have been paid. All of such shares are to consist of one class only.

The amount of capital with which this corporation shall commerce business shall not be less than \$500.00

ARTICLE V

This corporation shall commerce its existence on filing, and shall exist perpetually thereafter unless sooner dissolved according to law.

No contract or other transaction between this corporation and any other corporation, and no act of this corporation, shall in any way be affected or invalidated by the fact that any of the directors of this corporation are peculiarly or otherwise interested in, or are directors or officers of such other corporation, any director individually, or any form of which any director may be a member, may be a party to, or may be peculiarly or otherwise interested in, any contract or transaction of this corporation, provide that he or such firm is so interested shall be disclosed or shall have been known to the Board of Director or a majority thereof, and any other officer of such other corporation, or who is so interested may be counted in determining the existence or a quorum at any meeting of the Board of Director of this corporation which will authorize any such contract or transaction with like force and effect as if they were not such director or officer of such other corporation, or no so interested.

ARTICLE XI

The private property of the stockholders shall not be subject to the payment of the corporate debts in any extent whatsoever. The corporation shall have a first lien on the share of its stockholders and upon the dividends due them for any indebtedness of such stockholders of the corporation.

ARTICLE XIV

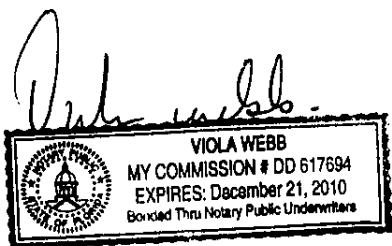


AMENDMENT

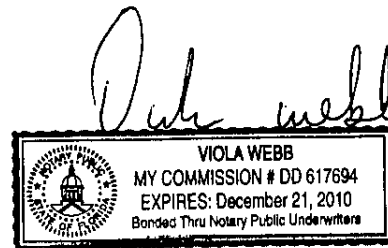
