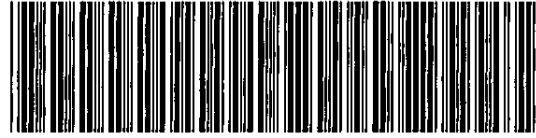





The undersigned incorporator hereby makes, subscribes to, acknowledges, and files these Articles of Incorporation for the purpose of organizing and incorporating a Corporation for profit under the laws of the State of Florida.

**ARTICLE I**

The name of the Corporation is DAYTONA FIBERGLASS REPAIR, INC., and it shall be hereinafter referred to as the "Corporation". The street address of the initial principal office and place of business of the Corporation is 2525 Palm Drive, Port Orange, Florida 32128, and the mailing address of the Corporation is 2525 Palm Drive, Port Orange, Florida 32128.

**ARTICLE II**

The time and date on which corporate existence of this Corporation shall begin is upon the filing of these Articles of Incorporation, and this Corporation shall have continuous and perpetual existence thereafter.

**ARTICLE III**

The general purpose for which the Corporation is organized is to transact any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes.


