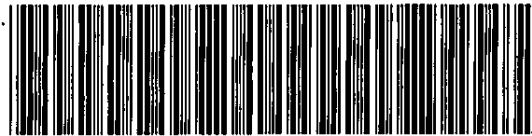

ARTICLE ONE

The name of this corporation is MIAMI CASUAL WEAR, INC. and the mailing address of the corporation shall be 14610 NE 6TH Avenue, North Miami, Florida 33161.

ARTICLE TWO

The date of the commencement of corporate existence of the corporation shall be the date these Articles are filed with the Secretary of State.

ARTICLE THREE

The duration of the corporation is perpetual.

ARTICLE FOUR




