# ARTICLE I. Name

The name of the corporation shall be K.E.L. TITLE INSURANCE GROUP, INC.

# ARTICLE II. Principal Office

The principal office and place of business of this corporation in the State of Florida shall be 151 WYMORE RD, SUITE 7000, ALTAMONTE SPRINGS, SEMINOLE COUNTY, FL 32714.

# ARTICLE III. Purpose

The corporation shall have the power and authority to transact title insurance as authorized under the laws of the State of Florida, as they now exist or may hereafter be amended, and to exercise any and all other lawful rights, powers, privileges and activities under the laws of the State of Florida or the United States.

# ARTICLE IV. Capital Stock

The maximum number of shares of stock that this corporation is authorized to issue is 10,000 shares of common stock, having a par value of \$1.00 per share. The corporation's surplus to policyholders shall be not less than the amount required under Florida law.
