The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I-NAME

The name of this Corporation is Dee Loop, Inc.

ARTICLE II-PRINCIPAL OFFICE

The name and street address of the incorporator are Dee Loop, 4333 Appleton Avenue, Jacksonville, Florida 32210.


ARTICLE VII-BYLAWS
