In compliance with the requirements of F.S. Chapter 607 and 621, the undersigned hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a professional service corporation as defined under F.S. Chapter 621.

ARTICLE I

The name of the Corporation is: N. PARKER PLATTS, P.A.

ARTICLE II

The street address of the principal office of the Corporation is: 11670 Twin Creeks Drive, Ft. Pierce, FL 34945.

ARTICLE III

The specific purpose for which the Corporation is organized is: to engage in real estate sales and to maintain a proper license as a qualified sales associate under the provisions of F.S. 475.161.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 500, no par value shares, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

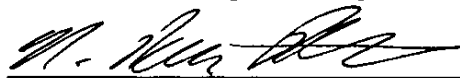

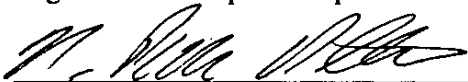
