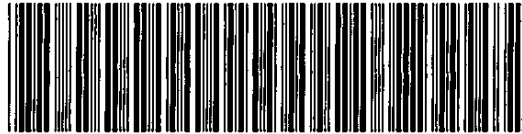

**ARTICLES OF INCORPORATION
OF
GLOBAL VISION PRODUCTIONS, INC.**

ARTICLE I - NAME

The street address of the initial principal office and mailing address of the Corporation is 2775 Stirrup Lane, Weston, FL, 33331.

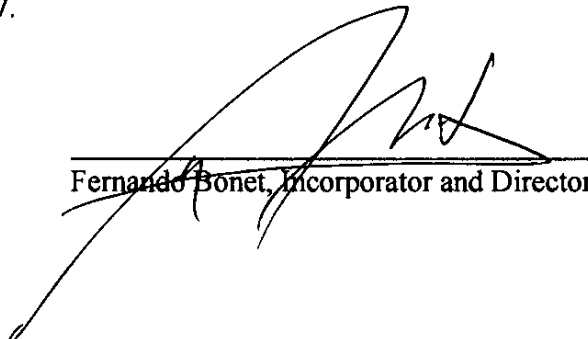
ARTICLE VI - INITIAL BOARD OF DIRECTORS
