

ARTICLE I - NAME OF CORPORATION

The name of the corporation shall be Frosty Top Express, Inc.

ARTICLE II - PRINCIPAL OFFICE

The principal office and mailing address of the corporation shall be 3437 S. St. Lucie Drive, Casselberry, Florida 32707-5509.

ARTICLE III - TERM OF EXISTENCE

The corporation shall begin its corporate existence as of the filling of these Articles of Incorporation and shall exist perpetually.
