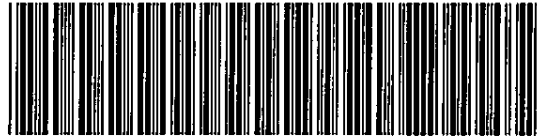

OF

ARTICLE ONE

The name of the corporation is K. N. A. B., INC.

The aggregate number of shares which the corporation shall have authority to issue is one thousand (1,000) of no par value.

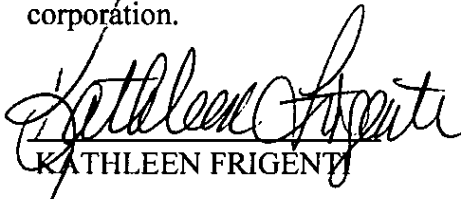
ARTICLE FIVE
