ARTICLES OF INCORPORATION For Allison Mason, M.S., CCC-SLP, P.A.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the Corporation is Allison Mason, M.S., CCC-SLP, P.A. Principal place of business is 1174 S.W. 149th Terrace, Sunrise, FL 33326.

ARTICLE II: DURATION

The existence of the Corporation shall commence with the filling of these Articles. The duration of the Corporation is perpetual.

ARTICLE III: PURPOSE

The Corporation may engage only in the licensed financial services activity or business permitted under the laws of the United States and the State of Florida. The purpose is for a licensed speech pathologist.
