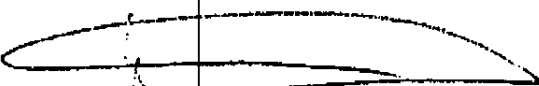

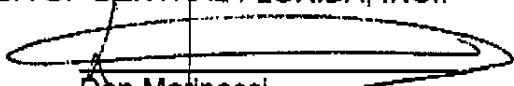
That the corporation named in Article I now hereby notifies the State of Florida as follows:
