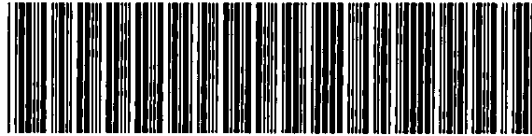

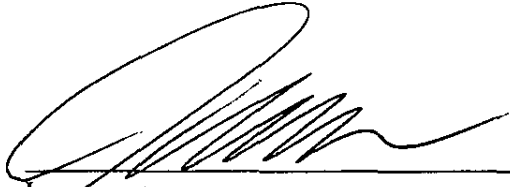

**ARTICLE VI**

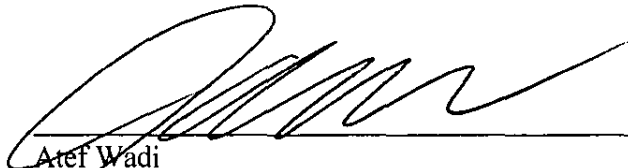
