**ARTICLES OF AMENDMENT TO  
THE ARTICLES OF INCORPORATION OF  
SPACE COAST OPTICAL, INC.**

These Articles of Amendment are made to the Articles of Incorporation of Space Coast Optical, Inc., a Florida corporation (the "Corporation").

- I. The name of this corporation is Space Coast Optical, Inc.
- II. The Articles of Incorporation of the Corporation are hereby amended as follows:

- A. Article I is hereby amended to delete "Space Coast Optical, Inc." and substitute therefor "Invision Billing and Financial Services, Inc."
- B. Article III is hereby deleted in its entirety and replaced with the following:

**"Article III**

The corporation is organized for the purpose of transacting any or all lawful business for which corporations may be incorporated under Chapter 607, *Florida Statutes*."

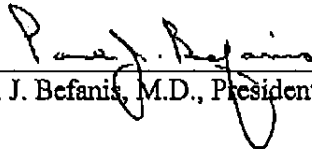
