**ARTICLES OF INCORPORATION
OF
VINYL & FABRICS, INC.**

We, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida, by and under the Provisions of the Statutes of the said State of Florida.

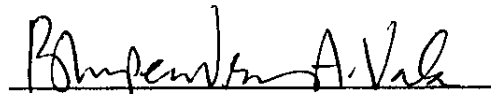

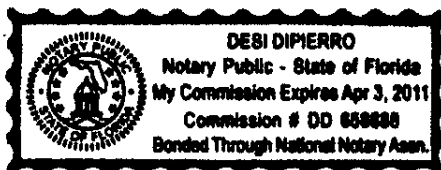

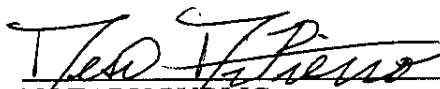
