ARTICLE I. CORPORATE NAME

The name of this corporation is: Cyberinformatix, Inc.

ARTICLE II. NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.

ARTICLE III. CAPITAL STOCK


ARTICLE X. AMENDMENT

ARTICLE XI. EFFECTIVE DATE


These Articles of Incorporation shall be effective May 1, 2007, as provided by Florida Statute 607.0123.
