

ARTICLES OF INCORPORATION OF ELITE RAD RADIOLOGY SERVICES, INC.

The under signed, for the purpose of forming a corporation under the laws of the State of Florida, hereby adopt the following Articles of Incorporation.

ARTICLE I: NAME

The name of this corporation shall be Elite Rad Radiology Services, Inc.

ARTICLE II: DURATION OF BUSINESS


ARTICLE X: SEAL




