The undersigned subscriber to these Articles of Incorporation hereby forms a corporation under the Florida Professional Service Corporation and Limited Liability Company Act.

**ARTICLE I - NAME**

The name of the corporation is Goldstein & Ray, P.A. (the "Corporation").

**ARTICLE II - EFFECTIVE DATE**

These Articles of Incorporation shall be effective on the date filed with the Department of State.

**ARTICLE III - ADDRESS**

The mailing address and principal office of the Corporation is 100 Northeast Third Avenue, Suite 400, Fort Lauderdale, Florida 33301.

**ARTICLE IV - NATURE OF BUSINESS**


**ARTICLE VIII - INCORPORATOR**


**ARTICLE IX - INCORPORATION OF PROVISIONS OF PROFESSIONAL SERVICE CORPORATION ACT**
