ARTICLES OF INCORPORATION OF

ARTICLE I - NAME OF CORPORATION

The name of the corporation is **JALSAM CORP.**

ARTICLE II - NATURE OF BUSINESS CONSULTING BUSINESS

The corporation is authorized to conduct any lawful business in the State of Florida which is not prohibited by law, rule or regulation.

The initial address of the principal office of the corporation is to be at 7761 Doubleton Drive, Delray Beach, Florida 33446.


The Board of Directors may from time to time designate such other address and place for the principal office of this corporation as it may see fit.


