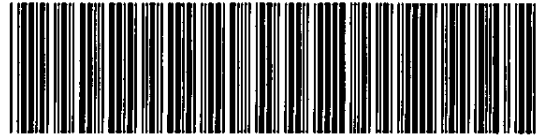

ARTICLE I
CORPORATE NAME

The name of this corporation is:

NATURE OF BUSINESS AND POWERS


